COMMISSION ON THE STATUS OF WOMEN • 4-15 MARCH 2013 Elimination and prevention of all forms of violence against women and girls

In early March, I was among 17 CFUW members from across Canada who attended CSW57, the 57th session of the Commission on the Status of Women at the United Nations in New York. The Commission operates within the UN Economic and Social Council (ECOSOC) of which CFUW is a member. The theme was "Elimination and prevention of all forms of violence against women and girls", a topic on which CFUW has many policies.

As a first-time attendee, the size and scope of the event was almost overwhelming, with over 5,000 delegates on site from around the world. There were delegations from UN member states and NGOs (Non-Governmental Organizations) such as CFUW. The task of the NGOs is to influence the work of the member states as they debate the issues and strive to reach agreed conclusions. While the formal sessions were happening inside the UN, parallel events were offered by the NGOs. I attended two events sponsored by CFUW ("Women's Right to Freedom from the Violence of Prostitution" presented by CFUW Vancouver and "Gendering the UN Convention Against Torture and Non-State Torture Victimization" presented by CFUW Truro and Women Graduates USA), as well as events that addressed aspects of violence against women in Afghanistan and in Scandinavian countries. It was exciting for me to sit in on one of the formal sessions chaired by Michelle Bachelet, and exhilarating to join my UN sisters in a march through the streets of New

York on International Women's Day.

I was moved by the courage of women from around the world who attended this UN session at considerable personal risk - the woman from Iran who had been arrested and detained upon returning home the last time she attended this UN meeting, the woman from Egypt who said that women there are not giving in, even as their freedoms are quickly being taken away.

In the end, I learned how advocacy works on the world stage. It begins with us here at home when we draft resolutions that we hope will become CFUW policy. I saw firsthand how CFUW policies make their way to the UN. Although there are no easy solutions to the worldwide problem of violence against women, our work is important and does make a difference.

What Do All Those Labels Mean?

Shopping for food that is good for us can be confusing. Supermarket shelves are lined with items labelled *ORGANIC*, *NATURAL*, *NO ADDED*

PRESERVATIVES, GRAIN FED, HEALTHY. How do we sort them all out?

rargeting

Health Canada (HC) and the Canadian Food Inspection Agency (CFIA) are responsible for food labelling regulations. Health claims on food labels must be accurate, have a scientific basis, and should not be misleading¹. However, there are no enforceable standards for some claims.

ORGANIC: Foods so labelled have been independently verified by a CFIA-accredited certification body and meet the following criteria²:


- Fruit, nuts, vegetables, grains no synthetic pesticides, fertilisers or sewage sludge used; not irradiated; not genetically modified (GM).
- Meat, poultry, milk, eggs no growth hormones or prophylactic antibiotics used; not irradiated; not cloned; fed only organic feed and never animal by-products; animals have access to outdoors and grazing; treatment meets animal welfare requirements.
- Seafood (farmed) no growth hormones, herbicides or antibiotics; not GM; limited stocking density; pesticides restricted; fed organic fishmeal and never GM ingredients; no colouring or synthetic flavour enhancers; treatment meets most animal care requirements.
- Packaged foods at least 95 percent of ingredients are organic.

The following categories and their claims have not necessarily been verified2:

- **NATURAL:** Foods and ingredients have not been significantly changed in any way; no added vitamins, minerals, artificial flavours or other food additives.
- **GRAIN FED:** Animals have been fed only grain and grain products; feed is free of any ingredients of animal origin.
- NO ANIMAL BY-PRODUCTS: Animal has not been fed any ingredients of animal origin.
- RAISED WITHOUT ANTIBIOTICS, RAISED WITHOUT HORMONES: Animals have not been given these drugs (NOTE: pigs and poultry are never given hormones).
- GRASS FED, FREE RANGE, FREE RUN, CAGE FREE, PASTURE RAISED: These terms have no legal definitions. The Society for the Prevention of Cruelty to Animals can certify animals raised humanely: they must have generous space; no growth-promoting antibiotics or electric prods can be used; and, pain medication is required for de-horning and castration². Hens are cage-free; cattle have access to outdoors; sows must not be kept in gestation stalls.
- **HEALTHY:** No legal definition **BEWARE!** Read the label what is low in fat may be high in sugar and *vice versa*; "no preservatives" may yet include nitrites; "contains Omega-3" may mean an insignificant amount; "25 percent less sodium" may apply to a surprisingly small serving size.

OPPORTUNITY TO NAME NEW SCHOLARSHIP

The new CFUW-Ottawa scholarship for a woman with a disability is in search of a name! Because it is being funded through contributions from the membership, it has been called the Members' Gift Scholarship. Fran Harding, the founder of the scholarship, thinks there may be a member or members



who might like to name the award for a friend, a colleague or a family member.

"Buildings and athletic venues are often named for a donor or to honour someone. Why couldn't we do this with the scholarship? CFUW-Ottawa Decisions on 2013 CFUW Policy Resolutions

Sixty people attended the CFUW-Ottawa Resolutions Meeting on April 8, 2013. We thank all members who contributed to the review of the resolutions proposed for 2013 and all who attended this important meeting, especially the Madri-Gals. who provided a musical finale. Five CFUW resolutions were presented, discussed and voted upon. Three were approved as amended, one was rejected, and one was approved without amendment. Here are our final results:

1. BULLYING AND CYBERBULLYING (Montreal Lakeshore UWC) Presented by Maria Neil APPROVED AS AMENDED TO READ:

BULLYING AND CYBERBULLYING: A NATIONAL PREVENTION STRATEGY

RESOLVED: That the Canadian Federation of University Women (CFUW) urge the federal, provincial, territorial and municipal governments of Canada to reduce and prevent bullying and cyberbullying by:

- (i) Raising public awareness about the harm caused by bullying and cyberbullying and enforcing legislation already in place:
- (ii) Requiring educational institutions to train educators and counselors to recognize and address bullying and cyberbullying, integrating such training into core curricula and professional development; and
- (iii) Clarifying the Criminal Code to include cyberbullying communication by means of a computer under the areas of criminal harassment, false messages and defamatory libel, and including restorative justice initiatives as part of the national prevention strategy.
- 2. HYPER-SEXUALISATION: COUNTERING EXPLOITATIVE CHILD IMAGES (CFUW Cornwall and District)

Presented by Sue Wilson APPROVED AS AMENDED TO READ:

HYPER-SEXUALISATION: COUNTERING EXPLOITATIVE CHILD **IMAGES**

RESOLVED, That the Canadian Federation of University Women (CFUW) urge the Government of Canada and the provincial, territorial and aboriginal governing bodies to protect children from sexualisation by:

- (i) establishing and enforcing laws that prohibit the use of sexualized images of prepubescent and adolescent children in media;
- (ii) developing an educational program to raise awareness of hypersexualisation of children, especially girls, in advertising, commercial products, and mass media, and its adverse effects on self-image and healthy development;
- (iii) developing media literacy that counters sexist socialization; and
- (iv) allocating resources to programs that (a) expose the relationship between hyper-sexualisation and gender inequality in society; and (b) support positive role models and the positive depiction of women.

3. THE NEED FOR A FEDERAL COMMISSIONER FOR CANADA'S **CHILDREN** (CFUW South Delta)

Presented by Maria Neil APPROVED AS AMENDED TO READ:

ESTABLISH THE OFFICE OF THE COMMISSIONER FOR CHILDREN **AND YOUNG PERSONS**

RESOLVED: That the Canadian Federation of University Women (CFUW) urge the Government of Canada to:

(1) Establish an independent federal Children's Commissioner with necessary resources to conduct comprehensive and systematic monitoring

- of all children's rights and to ensure the implementation in Canada of the UN Convention on the Rights of the Child (the UNCRC) ratified by Canada in 1991:
- (2) Promote public education about the UNCRC and ensure the rights of all children in Canada; and
- (3) Review all Canadian legislation for compliance with the UNCRC and all other international conventions which Canada has ratified including the UN Optional Protocol to the Convention on the Rights of the Child on the Sale of Children, Child Prostitution and Child Pornography, the UN Convention against Transnational Organized Crime and its Protocol to Prevent, Suppress and Punish Trafficking, and the UN Convention on the Elimination of Discrimination against Women; and to implement fully all the terms of these documents.

4. AN ADEQUATE INCOME FOR ALL CANADIANS (CFUW Guelph) Presented by Lynne Bond NOT APPROVED

RESOLVED, That the Canadian Federation of University Women urge the federal, provincial and territorial governments to implement a basic income program that ensures that all adult residents of Canada, as defined for tax purposes, receive an income adequate for the necessities of life including safe housing. nutritious food, clothing, transportation and other basic needs.

Rationale for non-approval: CFUW-Ottawa supports the intent of the resolution. We agree that Canada needs a program(s) that would provide adequate incomes for Canadians, and applaud the work that the proposers have done on this difficult issue. However, our members were concerned that the terms were not clearly understood. CFUW already has policy on poverty, and this resolution calls for a different approach but we need more precise definitions and more clarity of concepts before we can support it.

5. REDUCTION OF DIETARY SODIUM (CFUW Ottawa)

Presented by Dorothy Phillips Approved without amendments to

REDUCTION OF DIETARY SODIUM

- 1. **RESOLVED**, that the Canadian Federation of University Women (CFUW) urge the Government of Canada to amend the Food and Drug Regulations to change the basis of the Daily Value (DV) for sodium calculations on food labels from 2300 mg to 1500 mg to reflect the current Adequate Intake (AI) level.
- 2. RESOLVED, that CFUW urge the Government of Canada to work with the food industry to establish sodium reduction targets by food category so that Canadians can consume a healthy, varied diet without exceeding the current Adequate Intake (AI) for sodium levels (1500 mg/day for adults)
- 3. RESOLVED, that CFUW urge the Provincial, Territorial and Municipal governments to establish sodium levels for food services and restaurant food so that Canadians of all ages may enjoy healthy meals in restaurants, institutions and cafeterias without exceeding age-appropriate recommended sodium levels.
- 4. RESOLVED, that CFUW urge the Government of Canada and the Provincial, Territorial and Municipal governments to promote public awareness of healthy, age-appropriate levels of sodium consumption based on the current Adequate Daily Intake (AI) (1500 mg/day for adults).

Supporting HIPPY Ottawa – A CFUW-Ottawa Club Project

Now completing its second full year, the CFUW-Ottawa Club Project to Support the HIPPY Ottawa Program (Home Instruction for Parents of Preschool Youngsters) continues to be very suc-


cessful. Over the past year HIPPY Ottawa served 56 parents and 68 children.

Eighteen CFUW-Ottawa volunteers provided:

- help at monthly meeting/event for the HIPPY families throughout the school year. Duties include: childcare, greeting and registration of families, food preparation and cleanup, and general interaction with the HIPPY families, most of whom are recent immigrants to Canada;
- administrative duties for the HIPPY Ottawa Program Coordinator on a weekly basis; and
- assistance to the HIPPY Ottawa Program Coordinator with event themes/topics and logistical advice in planning events, coordinating our volunteers for each event.

Feedback from the HIPPY Program Coordinator on CFUW-Ottawa support received has been extremely positive and heartfelt. CFUW-Ottawa members have proven themselves to be a reliable, flexible and caring volunteer work force and were ready to step up to the challenge of the Program increasing the number of families this year. We're looking forward to another rewarding year next year.

SPRING ISSUE OF DIPLOMAT MAGAZINE FEATURES UWHAW

A smiling picture of Dr. Sima Samar, the remarkable physician whose dedication inspired the formation of CFUW-Ottawa's University Women Helping Afghan Women, tops Dianne Rummery's excellent article about the commendable work of UWHAW, originally published on page 20 of the Spring 2013 issue of *Diplomat & International Canada*.

The "Road to Istanbul" (see also article on page 10 of this issue) and the myriad successful activities the group has undertaken since its beginnings in 2010, are described, including wide-ranging study, advocacy and fundraising for girls' education.

The article points out that CFUW, founded in 1919, has kept a wary eye on the Canadian government since the early days of women's emancipation. The UWHAW Study and Interest Group is part of the pattern of vigilance and voice that CFUW has effectively sustained to this day.

The quarterly glossy magazine that targets diplomatic missions in the National Capital Region, is edited by Jennifer Campbell, who also writes a column in the Citizen called *Diplomatica*, where our Diplomatic Hospitality Group has often appeared, as have members of UWHAW.

Frowing up in Canada 100 Years Ago

Dorothy Horwood, one of our longtime active members and generous scholarship donor, has recently written a memoir of her mother, Monica Philbrick Flannery (1898-1996), in photo below left. *From Monica with Love: Sketches of the life of an English Quebecer in the early 20th Century*, based on Monica's letters, notes and conversations with Dorothy, was published in 2013 by Baico Publishing.


On the education of girls at that time, Dorothy summarizes from

the book: "My grandfather, who was born about the time of Confederation, was ahead of his time in advocating that women should be educated. He believed that every girl should have some way of earning a living should she have the need to do so. Thus, it is nearly 100 years since he followed his own advice and gave each of his four

daughters a college education. My mother, Monica and her sister, Reuby, went to Macdonald College, McGill University

and became teachers. Harriet attended Bishop's University and became a French specialist, and Charlotte went to Stanstead College and learned business practice".

However, Dorothy adds, her grandfather controlled the paths which his daughters followed. Though her mother really wanted to be a nurse and help the



war effort, he refused because a cousin of his had died while training to become a nurse at the Royal Victoria Hospital in Montreal. She had contracted scarlet fever in the Contagious Diseases Department.

The options for women in those days were few. A woman's career ended when she married.

Ontario Council Standing Committees Meetings - March 16, 2013

The morning session of the CFUW Ontario Council meeting in Toronto on March 16 addressed "Human Trafficking - Control, Exploitation, Profits".

Karlee Anne Sapoznik, President and Co-Founder of the Alliance Against Modern Slavery, Aura Burditt, Chair of the London Anti-Human Trafficking Committee, and Loly Rico, President of the Canadian Council of Refugees, gave comprehensive and detailed presentations that addressed the problems associated with human trafficking: sexual servitude, servile forced marriage, and the vulnerability of immigrant women working as domestics.

Coercion of victims in the sex trade is both mental and physical, and can include tattoo branding. Often victims are moved around from one city to another, which further isolates them. Organized crime is deeply involved worldwide and realizes enormous profits through trafficking. In Ontario, groups like Hell's Angels are active. Victims include foster children, those who suffer from drug addiction and mental illness, who are poor, who lack education. Many victims are young native women. It is estimated that there are as many as 27 million persons in slavery worldwide.

There is a great need for victim support services. Education is a key element in rehabilitation and protection. It takes about three to five years to achieve a successful outcome. Law enforcement personnel, judges and social service workers all have important roles to play. Recently in Hamilton, RCMP constable Lepa Jankovic was instrumental in uncovering Canada's largest known human trafficking ring. The groundbreaking case led to arrests of three traffickers and rescue of 23 victims.

The afternoon session of the Standing Committee on Status of Women

and Human Rights continued discussion on human trafficking. **Stan Burditt**, founder of Men Against Sexual Trafficking (MAST), spoke about his work. Like any business, sex trafficking is driven by demand. The goal of MAST is to educate men about the harm being done to the souls and dignity of innocent victims.

The guest speaker at the afternoon meeting of the Standing Committee on Education was Mary Jean Gallagher, Assistant Deputy Minister and Chief Student Achievement Officer, Ontario Ministry of Education. She leads the Ontario Government's drive to improve student achievement, specifically in literacy and mathematics as measured by province-wide testing. Much of her work is with school boards, as the Ministry of Education is currently attempting to broaden the dimensions of math education. Ontario students continue to improve on national norms

and are among the best on international norms. The high school graduation rate has increased considerably over the past five years.

On the Road to Istanbul

As members of University Women Helping Afghan Women (UWHAW) became increasingly aware of the culturally complex and perilous society in which Afghan women live, they were convinced that the future of these girls had to be on the agenda of the IFUW Triennial in August 2013.

Continuing research, extensive networking internationally, hundreds of emails and much wordsmithing later, education for Afghan women will be featured in a Seminar scripted by UWHAW, in a five affiliate Workshop with Canada in the lead, in a Resolution from Australia and Britain which Canada will second, and hopefully, with the initiation of an Afghan federation.

The Seminar will examine extreme inequalities in educational opportunities for girls and how they jeopardize a sustainable future for Afghanistan, a lead in to the Workshop that follows the same day. Created and partnered by multi-affiliates, the Workshop will hopefully be more powerful than one led by a single federation.

Getting this kind of international engagement wasn't an easy task. To begin, UWHAW sought to interest CFUW

members across the country with special sessions on this issue at the CFUW AGMs in St. John's, 2011, and Victoria, 2012. IFUW members attended both sessions

and when U.K. and Australian members suggested a resolution regarding Afghan women for Istanbul, they were referred to us. An electronic conversation began which grew over time to include Rwanda, the U.S., as well as the U.K. and Australia.

The Seminar preparation, while lengthy, was in-house; getting interna-

> tional co-operation on the Workshop was another issue. In the end, Hally Siddons, Leila Metcalf and Norma Pike prepared a draft proposal.

A family holiday in Australia allowed Hally to meet with IFUW affiliate contacts from Rwanda and Australia - first meeting with Rwandans in Sydney, and

> then, with Australians in Perth (see photo to the left). Both approved our Ottawa proposal, wanted to join our efforts and contributed further ideas.

> With three affiliates on board, the proposal was sent to contacts in the U.K. and the U.S. who also agreed to join us.

> To quote the workshop proposal:

> "In keeping with the conference theme and IFUW policy, this workshop will focus on sustainability in education for Afghan

girls and women. A sustainable system of education can lead to lasting economic and social development for all. The workshop will present and identify possibilities to help Afghan girls and women overcome educational barriers. The format will be participative. Canada will chair; five affiliates will partner; panel members will present actions that work. Following a breakout session, the workshop will conclude with a plenary to generate ideas for action back home."

We are particularly pleased that our inspiration, physician and activist Dr. Sima Samar, will join us at both the Seminar and Workshop to be the Afghan voice.

A successful Resolution will also live on after the Triennial to call attention not only to the right of education for Afghan girls and women but indeed the right to education for all people.
