# Proposed Amendments to the CFUW-Ottawa Constitution and Bylaws

At the General Meeting on Feb. 4, I outlined, for information purposes, the proposed amendments to CFUW-Ottawa's Constitution and Bylaws.

At the CFUW AGM in Victoria in June 2012, the CFUW Articles and Bylaws (formerly called the CFUW Constitution and Bylaws) were amended to eliminate the "Associate Member" membership category (i.e. member without a university degree). Accordingly, the CFUW Bylaws, Section C. Membership, Article 7, now reads, "There shall be one class of member in CFUW."

The amendments being proposed to the relevant Membership sections of CFUW-Ottawa's Constitution and Bylaws are" housekeeping" in nature, bringing CFUW-Ottawa into conformity with the Articles and Bylaws of CFUW.

The proposed amendments to the CFUW-Ottawa Constitution 2006, Article II - Purpose, Sections 4 and 6 will replace the terms "women university graduates" and "university women" with the term "members".

The proposed amendments to CFUW-Ottawa Bylaws 2012, Article 1 - Membership, Sections 1, 2, 3 and 8, are in the same vein, i.e., the removal of wording relating to "Associate Member" and to the requirement of a university degree for membership in the Club.

Currently CFUW-Ottawa's Bylaws state that 25 percent of the members do not need to have university degrees. It is being proposed to reduce this to 20 percent of the members, to be in accordance with CFUW Bylaws.

The proposed changes were approved by the CFUW-Ottawa Board of Directors on Jan. 14, 2013 and will be on the agenda of the Annual General Meeting on May 7, 2013.

## **Medicine: A Glimpse of the Future**

A large crowd of members and friends came out on a cold evening on Feb. 4, to hear our speaker, Dr. Robert Roberts, President and CEO of the University of Ottawa Heart Institute and Director of the Ruddy Canadian Cardiovascular Genetics Centre. Dr. Roberts has had a distinguished career as a cardiologist, educator and scientist, is the author of numerous articles and studies, and the recipient of many awards. His research interest is in the field of molecular biology and genetics, and his work and that of his colleagues has led to the discovery of many genes responsible for heart disease, opening the door to new ways of predicting and treating heart disease. His presenta-

tion "Medicine: A Glimpse of the Future" showed in a clear and interesting way how genetics affects the diagnosis and treatment of disease. He began by saying that he believes we are on the verge of an exciting "golden era" in medicine and forecasts the rise of "personalized medicine" in which simple blood tests will be able to indicate genetic predisposition to disease and make possible early diagnosis. Heart disease may then be seen as preventable, and could be eliminated within this century. Dr. Roberts' presentation was stimulating and informative, making a complex topic accessible to the audience.

### Ontario Council Standing Committee Meetings – Jan. 19, 2013

The CFUW Ontario Council Standing Committees in Legislation, Education, and Status of Women and Human Rights were developed to keep members aware of current issues in Ontario. The Standing Committees meet three times a year – in September, January, and March in downtown Toronto. All Club members are invited to attend these meetings. CFUW-Ottawa was represented at the January CFUW Ontario Council Standing Committee meetings by President Nancy DeVillers and VP Liaison Charlotte Rigby. The topic was: Student College/University Math Preparedness.

The morning plenary session topic was the *College Mathematics Project 2011* that identified factors that affect mathematics performance of first-semester college students. The next step, the *College Student Achievement Project* is designed to increase math skills of young women, especially those entering skilled trades and other fields where math is a major requirement.

The afternoon sessions of the three Standing Committees continued the discussions:

Legislation Committee members worked through a variety of financial scenarios, using the financial literacy materials produced last year by the University Women's Club of Montreal.

Education Committee members continued the discussions on recommended changes to the Ontario school curricula to enhance student success.

Status of Women and Human Rights members reviewed factors affecting our 2012 CFUW Resolution "Retention and Promotion of Women in Skilled Trades and Nontraditional Occupations." We began with the film *Standing on Her Shoulders* about women in leadership in the Canadian Auto Workers Union (CAW).

Mary Ferguson presented an overview of the *Promising Practices* guide for recruiting and retaining women in trades, technology and sciences. The guide identifies three stages: 1. Exploring Opportunities and Career Paths; 2. Preparing and Bridging Women to Work; and, 3. Promoting Workplace Retention for Women (see <a href="https://www.workplaceskills.ca/promisingpractices">www.workplaceskills.ca/promisingpractices</a>.) Carpenters Joanna Belajac and Lorraine McDowell described their career challenges, including difficulty in obtaining the apprenticeships they require to become master carpenters.

Canada has a severe shortage of skilled tradespeople. We need more women in the trades, but bias is still an important employment equity issue for women in non-traditional occupations. CFUW believes that the Government of Canada should provide leadership, in partnership with provincial and territorial governments, business, labour, and industry stakeholders, to remove barriers to women's entry and advancement in the skilled trades, and to create workplace cultures that include women. The national strategy should include:

- Supports for women in non-traditional fields throughout their education, training and careers;
- Workplace behavioural/cultural change, driven by industry leaders and trade associations;
- Replacement of HR policies that are systemic barriers to the employment and retention of women, with more inclusive pay equity and "familyfriendly" policies;
- Identification and removal of barriers to women entering non-traditional fields of study; and,
- Sustainable funding to ensure implementation.

The next Standing Committee meetings on March 16 will focus on human trafficking. If you'd like to attend, please contact me.



# Food-Borne Diseases: Food Handling Safety

Food-borne diseases are no joke! They result from consuming contaminated food or beverages, and have short and long term health impacts. It is important to remember what you can do as a consumer to protect yourself and your family. Wash produce using clean water or produce wash available in health food stores (not detergents). Also, you may soak produce for 15 minutes in a solution of 2 tablespoons of salt and lemon juice or

If you must use a sanitizer, be sure to choose one that contains &gt;60 percent alcohol (not triclosan).</li> <li>□ Change dishcloths daily. Keep sponges bacteria-free by washing them in the dishwasher. Clean and sanitize surfaces before and after food handling. Wash cutting boards in the dishwasher, or spray them with a mixture of 5 ml bleach in 750 ml water,</li> </ul>	vinegar in a large container of water to destroy at least some pesticides; rinse well. Use a produce scrub brush before cutting firm-skinned produce (carrots, potatoes, melons and squash). Do not wash them in your sink, as it can harbour bacteria.   Keep pets away from food storage and preparation		
	areas.  □ Persons with infections should use separate dishes, cutlery, and glasses.		
let sit for 10 minutes, scrub with a nylon bristle brush, rinse well and air dry. Use separate cutting boards for ready-to-eat foods and for raw meat, poultry, and seafood. Discard boards with deep cut grooves in the surface.	□ Unpasteurized products like raw milk, fruit juice, or cider can contain harmful microbes. Like all food, powdered infant formulas are not sterile products and need to be handled properly. # Proposed 2013 CFUW Draft Resolutions

1: BULLYING AND CYBERBULLYING (Montreal Lakeshore UWC)

**RESOLVED**, That the Canadian Federation of UniversityWomen (CFUW) urge the federal, provincial, territorial and municipal governments of Canada to establish a framework to:

- (i) Raise public awareness about bullying and cyber-bullying and the legal remedies already in place;
- (ii) Discourage and deter bullying and cyber-bullying, and ensure that educational institutions establish or develop programs which train educators and counselors to recognize and address bullying and cyber-bullying by integrating such training into their core curriculum and also into ongoing professional development.

# 2: HYPER-SEXUALISATION: COUNTERING EXPLOITATIVE CHILD IMAGES

(CFUW Cornwall and District)

**RESOLVED**, That the Canadian Federation of UniversityWomen (CFUW) urge the Government of Canada to implement and enforce laws that prohibit the use of sexualized images of prepubescent and adolescent children in media.

**RESOLVED**, That CFUW recommend a nationwide education program be designed to raise Canadians' awareness of the hyper-sexualisation of children, especially girls in advertising, commercial products, and mass media.

**RESOLVED**, That CFUW urge the Government of Canada to develop media literacy that counters sexist conditioning and provides positive role models as a fundamental part of a National Action Plan to EndViolence Against Women and Girls.

**RESOLVED**, That CFUW urge the Government of Canada to allocate resources to support programs that expose the relationship between hypersexualisation and gender inequality in society. **RESOLVED**, That CFUW urge the Government

**RESOLVED**, That CFUW urge the Government of Canada to allocate resources to programs that support the positive depiction of women.

3: THE NEED FOR A FEDERAL COMMIS-SIONER FOR CANADA'S CHILDREN (CFUW South Delta)

**RESOLVED**, That the Canadian Federation of University Women (CFUW) urge the Government of Canada to:

- (1) Take the necessary measures to establish the office of an independent federal Children's Commissioner with the necessary human, technical and financial resources to secure its independence and efficacy in conducting comprehensive and systematic monitoring of all children's rights and to ensure the implementation of the UN Convention on the Rights of the Child in Canada.
- (2) Promote public awareness and education about the United Nations (UN) Convention on the Rights of the Child and in particular of the need to ensure the implementation of the rights of Aboriginal and other marginalized children in Canada.
- (3) Review all legislation for compliance with the Convention on the Rights of the Child (CRC) and other international conventions and protocols which Canada has ratified including the UN Optional Protocol to the Convention on the Rights of the Child on the Sale of Children, Child Prostitution and Child Pornography and the UN Convention against Transnational Organized Crime and its Protocol to Prevent, Suppress and Punish Trafficking, and to fully implement the terms set out within these documents.

# 4: AN ADEQUATE INCOME FOR ALL CANADIANS

(CFUW Guelph)

**RESOLVED**, That the Canadian Federation of University Women urge the federal, provincial and territorial governments to implement a basic income program that ensures that all adult residents of Canada, as defined for tax purposes, receive an income adequate for the necessities of life including safe housing, nutritious food, clothing, transportation and other basic needs.

# 5: REDUCTION OF DIETARY SODIUM (CFUW Ottawa)

**RESOLVED,** that the Canadian Federation of UniversityWomen (CFUW) urge the Government of Canada to amend the Food and Drug Regulations to change the basis of the Daily Value (DV) for sodium calculations on food labels from 2300 mg to 1500 mg to reflect the current Adequate Intake (AI) level.

RESOLVED, that CFUW urge the Government of Canada to work with the food industry to establish sodium reduction targets by food category so that Canadians can consume a healthy, varied diet without exceeding the current Adequate Intake (AI) for sodium levels (1500 mg/day for adults). RESOLVED, that CFUW urge the Provincial, Territorial and Municipal governments to establish sodium levels for food services and restaurant food so that Canadians of all ages may enjoy healthy meals in restaurants and cafeterias without exceeding age-appropriate recommended sodium levels.

**RESOLVED**, that CFUW urge the Government of Canada and the Provincial, Territorial and Municipal governments to promote public awareness of healthy, age-appropriate levels of sodium consumption based on the current Adequate Daily Intake (AI) (1500 mg/day for adults).
