

TRUST INDENTURE of the Canadian Federation of University Women – Ottawa
Scholarship Trust
Fund

Name of the Trust:

The Trust shall be named the Canadian Federation of University Women - Ottawa Scholarship Trust Fund.

Definitions:

“Club” means the Canadian Federation of University Women - Ottawa, also referred to as CFUW - Ottawa. “Fund” means the Canadian Federation of University Women - Ottawa Scholarship Trust Fund, also referred to as the CFUW STF and the Trust.

Part I Objective:

The CFUW-Ottawa Scholarship Trust Fund was established in 1983 by what is now called the Canada Revenue Agency as a public foundation (charitable trust). Financially, it operates at arm’s length from the Club, but it is the responsibility of the Board to maintain an awareness of the financial affairs of the Trust. The Scholarship Trust Fund has separate authorized banking officers from those of the Club.

The objective of CFUW-Ottawa STF is to encourage and support study and research of those seeking higher education by establishing, funding and disbursing scholarships and awards as described in Appendix A.

Part II Structure:

1. There shall be six Trustees:
 - a) Two Trustees, the Trust Treasurer and Trust Chair appointed by the Board of Directors of the Club and elected by the membership each year at the Annual General Meeting, to serve a term of four years, which may be renewed at the discretion of the Board of Directors
 - b, The Club Treasurer and the Convenor of the Fundraising Committee, appointed by the Board of Directors of the Club, to be Trustees during their terms of office as Club Treasurer and Convenor of the Fundraising Committee, respectively.
 - c) The Scholarship Convenor and the Secretary elected by the Trustees of the Fund, usually for a period of four years, but may be extended by vote of the Trustees of the Fund.

1.1 If a vacancy occurs for Trustees under 1a) and 1b), the Executive Committee of the Board of Directors of CFUW- Ottawa shall appoint a member of the Club to fill the unexpired term.

1.2 On every change in the trusteeship a list of the Trustees of the Fund shall be permanently attached to the Indenture and shall be signed by the persons named.

1.3 It is recommended that Trustees' terms be managed so that overlap and continuity are ensured on the Trust.

2. The fiscal year for the Trust is June 1st to May 31st.

3. Scholarships and awards shall be disbursed on a yearly basis from income derived from donations, fundraising and prudent, lowest risk possible investments held by the Fund

Part III Duties and Powers of the Trustees:

1. The Trustees shall meet at least three times a year to discuss the Trust business including overseeing the granting of the awards and scholarships and administration of the Fund.

1.1 The Trustees shall hold an Annual General Meeting (preferably concurrent with the regular Trust meeting in October) for the purpose of reappointing the Trust accountant (to conduct the year-end review), approving the Submission of the T3010 registered charity information return, and (re)appointing the six current trustees.

2. The Trust Treasurer shall keep proper books of accounts and shall present a detailed report and a financial statement to the Trustees on a regular basis, and then to the Club annually after the Fund's year-end.

3. The Trust Treasurer shall ensure that the preparation of the required annual compliance reporting is completed by established deadlines.

a) She will coordinate (usually with the accountant) to ensure the annual financial review of the Statement of Assets and Fund Equity and the Income Statement are prepared on a timely basis.

b) She will ensure the annual charity information is prepared (usually by the accountant).

c) She will be responsible for sending both the financial statement and the annual charity information return to the Canada Revenue Agency each year within six months of the end of the fiscal year.

4. The Trustees shall have the power to invest and to disburse the income from the investments to pay the awards and scholarships described in this Indenture for the purposes and objectives set out herein in accordance with the terms of the Ontario Trustees Act.

5. The Trustees reserve the right at any time to accept or decline gifts as may be paid to or transferred to the Fund by the Club or any person, either personally or by testamentary act or disposition.

6. The Trustees shall ensure that monies from the Fund are made available to fund the awards and scholarships.

6.1 The Trustees shall ensure that funds previously committed by an individual donor (e.g. on an annual basis) are reviewed in a timely fashion before the due date for disbursement.

7. The Trustees may, during the administration of the Fund, obtain the assistance of solicitors, accountants, investment advisors or other agents as they deem necessary, and may pay reasonable fees and expenses incurred in obtaining this assistance. The Trustees shall not be liable for any loss incurred as a result of any advice or recommendations given or not given, or received or not received, from such persons, or for failure to act or ask for advice or recommendations from such persons.

8. The Trustees may authorize the payment of reasonable expenses for the administration of the Fund.

9. The Trustees may obtain assistance from members of the Club as deemed necessary.

Part IV Quorum:

Any four Trustees shall constitute a quorum. Decisions of the Trustees shall be made by a Majority of the Trustees present at a meeting.

Part V Liability:

No Trustee, provided that she acts in good faith, shall be liable for any loss by the Fund, except for loss caused by her own dishonesty, gross negligence or willful breach of trust.

Part VI Amendments:

1. Subject to paragraph 2, the terms of the Trust Indenture may be amended a) by a majority vote of the Trustees, and

b) by a majority vote of the members of CFUW - Ottawa present at a regular general meeting, provided that prior notice of the amendments shall have been presented to the membership.

2. The Trustees may amend Appendix A in any of the following ways, provided that such Amendments take effect only upon written notification to the Club and to the Board of Directors:

a) By creating new awards or scholarships of specified amounts and specifying the eligibility criteria

b) By increasing the amounts of existing awards or scholarships

c) By amending the eligibility criteria of existing awards or scholarships, as long as they remain consistent with the objects and purposes of the Club and the Fund.

Appendix A – Statement of Objectives

The activities to be carried out by the Canadian Federation of University Women - Ottawa Scholarship Trust Fund are as follows:

Scholarships and Awards at the **University of Ottawa** –

All recipients are to be Canadian citizens or permanent residents of Canada except for the HOPE Scholarship for Refugee Women. Preference for all awards will be given to students who identify as women.

All recipients are to be registered for the full school year of study in which the award is announced.

1. **Constance Jones Scholarship in Women's Studies** (\$2,000) awarded to a woman with high academic standing, who is pursuing a full-time undergraduate program in Women's Studies.
2. **Helen Nininger Scholarship in Fine Arts** (\$2,000) awarded to a woman with high academic standing, who is pursuing a full-time undergraduate program in Fine Arts.
3. **L. Gladys Harvey Award** (\$2,000) awarded to a woman with a disability who is enrolled in a full-time undergraduate program.
4. **Charlotte Whitton Award** (\$2,000), 5) **Mary Kyles Award** (\$2,000), 6) **Lucille Muldoon Award** (\$2,000) and 7) **Muriel Axon Award** (\$2,000) awarded to undergraduate or graduate female students and who demonstrate good academic achievement and financial need.
8. **Lillian Gertsman Scholarship** (\$2,000) awarded to a mature woman studying Psychology at the undergraduate level.
9. **The Reid Memorial Scholarship** \$2,000 This scholarship is awarded annual to a full-time student in medicine at the University of Ottawa. The student must demonstrate good academic achievement and financial need. The scholarship is the gift of Marjorie Melick, a member of the Ottawa Club, in memory of her father, John Vicars Reid.
10. **Barbara Newbegin Award in Music** (\$2,500) awarded to a graduate Music student majoring in performance studies in an orchestral instrument, organ or piano, who has demonstrated financial need and academic achievement. Preference will be given to a woman.

11. **Barbara Newbegin Award in Mathematics** (\$2,500) awarded to a full-time undergraduate student in year 2 or higher of a co-op program in Mathematics or Statistics, who has demonstrated financial need and academic achievement. Preference will be given to a woman.
12. **Susan B. Davies Scholarship for Indigenous Student in Nursing** (\$3,000) awarded annually to a First Nations, Métis, or Inuit student, with high academic standing within the Graduate or Undergraduate Program of Nursing at the University of Ottawa. This funding is in place for five years, starting in September 2020 and ending September 2025.
13. **HOPE Scholarship for Refugee Women** (\$2,000) Awarded annually to undergraduate students who are or have been a Convention Refugee or a person in need of protection and are enrolled in any program of study at the University of Ottawa. Recipients must demonstrate financial need. Preference will be given to women. Endowed in 2022 by the Heads of Mission Spouses Association and the Canadian Federation for University Women-Ottawa.

Scholarships and Awards at Carleton University –

All recipients are to be Canadian citizens or permanent residents of Canada except for the HOPE Scholarship for Refugee Women. Preference for all awards will be given to students who identify as women

All recipients are to be registered for the full school year of study in which the award is announced.

Beginning in 2019-2020, Carleton University will match funds for a period of five years to the recipients of the non-endowed awards. However, awards for students studying part-time are capped at \$2,000. Therefore, there will be two recipients for each part-time award. The Centennial Scholarship of \$5,000 will also be awarded to two recipients.

1. **Harriet & Eugene Forsey Scholarship** (endowed \$4000) awarded to a graduate student in Political Science specializing in Canadian federal politics.
2. **Alice E. Wilson Scholarship** (\$2,000) awarded to a full-time graduate student in Engineering. If no recipient is found it may then be awarded to a female student in another STEM program.
3. **Helen Nininger Scholarship in Music** (endowed \$2,000) awarded to a student with high academic standing who is pursuing a full-time undergraduate program in Music.
4. **Dr. Ruth Bell Scholarship** (\$2,000) 5.) **Carol Shields Scholarship** (\$2,000) and 6.) **Naomi Raynor Scholarship** (\$2,000), awarded to women registered as part-time students. The winners must have demonstrated a high potential for university studies and have completed the equivalent of at least five courses beyond entrance requirements at the university.
7. **Shirley Greenberg Award** (\$2,000) awarded to a student who is a sole-support parent and who requires financial assistance to help meet educational costs.
8. **Dorothy Powell Scholarship** (\$2,000) awarded to a third-year student in Economics.
9. **The Ruth Bell Centennial Scholarship Honouring all Members of the Ottawa Club since 1910** (\$5,000) awarded annually to an honours student in Women's Studies (either as a single or double major), in third or fourth year, who demonstrates high academic achievement.

10. **The Susan Scott Parker Scholarship** (\$2,000) awarded annually to a registered undergraduate student with a disability who has demonstrated financial need and academic achievement.
11. **The Earl B. Connell Foundation Scholarship** (\$2,000) awarded annually to a student enrolled in the Bachelor of Music program, at any year-level, pursuing classical music studies. The scholarship is the gift of Hally Siddons, a member of the Ottawa Club, and her family in memory of their father.
12. **The CFUW National 100th Anniversary Scholarship** (endowed \$2,000) to a First Nations, Inuit or Métis full-time student in second year or above.
13. **Canadian Federation of University Women – Ottawa Bursary** (endowed \$2,000) Awarded annually to a full-time mature student in demonstrated financial need who is pursuing a Bachelor of Commerce degree with a concentration in Accounting. If in a given year there are no eligible students in the Accounting concentration, other Commerce students may be considered. Gift to the STF from Christine Narraway, a member of the Ottawa club. First year awarded 2020 – 2021.
14. **Heather Lewis Scholarship in Humanities** (endowed \$2,000) Awarded annually to an outstanding student enrolled in a degree program offered by the College of the Humanities. First year awarded 2020 – 2021.
15. **Barbara Newbegin Scholarship in Classical Music** (endowed \$2,000) Awarded annually, on the recommendation of the School for Studies in Art and Culture, to an outstanding full-time, student entering a Music program in classical music. First year awarded 2020-2021.
16. **Barbara Newbegin Scholarship in STEM Music** (endowed \$2,000) Awarded annually to an outstanding full-time undergraduate student. This scholarship will alternate each year between students enrolled in any program within the Faculty of Engineering and the Faculty of Science. First year awarded 2021-2022.
17. **Lynne Bond Memorial Bursary for Students with Disabilities** (\$2,000) awarded annually to an undergraduate student in demonstrated financial need enrolled in any program of study at Carleton University who has a disability.
18. **HOPE Scholarship for Refugee Women** (endowed \$2,000) Awarded annually to undergraduate students who are or have been a Convention Refugee or a person in need of protection and are enrolled in any program of study at the Carleton University. Recipients must demonstrate financial need. Preference will be given to women. Endowed in 2022 by the Heads of Mission Spouses Association and the Canadian Federation for University Women-Ottawa.

Scholarships at Algonquin College:

1. **The Sherrylyn Sarazin Scholarship** (\$2,000) awarded annually to a second year First Nations, Métis or Inuit student enrolled in a diploma course who shows financial need and a good academic standing.

2. **The Susan B. Davies Scholarship in Nursing** (\$2,000) awarded annually to a second year First Nations, Métis, or Inuit student, preferably a female, who has achieved the highest GPA in the Practical Nursing Program. Awarded from 2019/2020 – 2024/2025.

3. **The HOPE Bursary for Refugee Women** (\$2,000) awarded annually to a 2nd or 3rd year female student in a diploma program who is – in order of preference – a convention refugee, a protected person, or a permanent resident who was a refugee/protected person, who demonstrates financial need and is in good academic standing. In the first year (2022) preference is for the bursary to be given to a female student from Afghanistan.

4. **University Women Helping Afghan Women Legacy Bursary** (\$1,000) awarded annually to a 2nd, 3rd or 4th year female Afghan student in any diploma or degree program who is – in order of preference – a convention refugee, a protected person, a permanent resident, or Canadian citizen who was a refugee/protected person and who demonstrates financial need and is in good academic standing. Endowed in 2022 by the University Women Helping Afghan Women Interest Group of CFUW-Ottawa.

Other Scholarships and Awards:

Gladys Cameron Watt Award (\$500) – Third prize in the Canadian Playwriting Competition, which is sponsored by the Ottawa Little Theatre
