A Special Message from the President

Hello CFUW Members,

Yesterday I participated in a conference call with the CFUW Vice Presidents of Advocacy, International Relations, and Education along with our Executive Director, and it looks like a well-planned year of coordinated Advocacy will be forthcoming! I have just finished a conference call with the CFUW Advisory Committee to review the proposed contract with the writer whom we hope will be writing a book on the History of CFUW. This is a project that was delayed when the selected writer became ill and discontinued her work. Interviews took place over the summer and thanks to my cell phone I was able to take part in one from my birthplace, Flat Island in Newfoundland, now resettled, having engaged in a Finance conference call from my daughter's boat enroute to the island. Later today your Finance Committee meets with a full agenda when we welcome a new member Sue Foley-Currie, to the Committee. Sue is knowledgeable about financial matters, and has had considerable financial experience in her places of work, and with school trustees, hospital and other boards.

In my last message of September 5th I talked with you about the upcoming vote on the GWI proposal to amend the 2016 Triennial decision on dues increases and to vote on a proposal to increase dues by special payments due by June 30, 2018 and again by June 30, 2019. For CFUW these additional payments would be

approximately \$8.40 per member while the current dues of \$21.70 would continue and would be due in January of 2018 and 2019, bringing the total dues paid by CFUW to GWI at approximately \$30.10 per member per year. The GWI documents do not reference the period beyond 2019.

Our current CFUW dues cannot provide for a dues increase, but if the motion on dues increases passes, CFUW, as a GWI member, will have to address this challenge.

Two days ago, September 11th, CFUW received the motions from GWI and news that the vote of the NFAs, (including the CFUW Board on your behalf), will be held October 22-23, 2017.

While GWI has responded to our request that more time be given to NFAs to consult their Clubs they have not responded to our call to build into the timeline, opportunities for discussion among NFAs and for the option of proposing amendments as is often done with electronic voting.

The CFUW Board is analysing the financial papers that accompanied the motions, and will discuss these and other related issues at our special Board meeting scheduled for Monday, September 18th. We plan that information will be sent to you after the Board meeting and certainly before Friday, September 22nd and posted on the website.

In the meantime please note that we will need all Clubs to schedule a Club meeting for after September 21st, or arrange other means of obtaining member input, to discuss the GWI motions and to let us know your recommendations as to how CFUW should vote on each motion. We will streamline the method of obtaining this information from you i.e. whether you support or do not support each motion. Your comments will be welcomed as well. We will give you as much time as we can, but plan to have your input ready by October 16th.

Please watch for information on the motions and other further messages from CFUW relative to the various GWI motions.
